## New Journalism-Law Scholarships at U of D

Dean Carl M. Selinger of the University of Detroit School of Law announces awards of two new legal journalism scholarships for students.

Rótert E. Sullivan, Jr., of the class of '83 received the 1981-82 David L. Moffitt Scholarship for Outstanding Achievement in Legal Journalism and Scott R. Torpey, of the class of '82, received the David L. Moffitt Scholarship for Outstanding Editorial Achievement for 1981-82.

Also recognized for editorial accomplishment was Karen K. Eisenbrey, J.D., of the class of 1981. Susan A. Nelson, J.D. '80 of the Law Firm of Cummings, McClorey, Davis and Acho, was granted the journalism Scholarship for 1979-80, and Richard N. Sundquist, J.D. '80 of Cross, Wrock, Miller and Vleson, received the editorial Scholarship for 1979-80.

An honorary scholarship was also awarded to another recent editor of the *Michigan State Bar Corporation Finance and Business Law Section Journal*, Norbert T. Starr II, J.D. '79, who recently received an LL.M. in Taxation from New York University and who currently practices in Dallas.

Dean Selinger reported that these scholarships had been made possible by a grant from David L. Moffitt, of the class of 1979. The scholarships were awarded to staffers who had performed outstanding editorial and writing service on the *Michigan State Bar Corporation Finance and Business Law Section Journal*, a quarterly publication produced by the students at the University of Detroit School of Law for the Corporation, Finance and Business Law Section of the State Bar of Michigan.

The *Journal*, now in its sixth year of publication by U of D law students, provides Michigan business lawyers with articles and information on current issues of commercial and banking law in the state.

Professor Patrick Keenan, Editor-in-Chief of the *Journal*, commented: "Our *Journal* is well-received by the Bar, and its recent inclusion in the nationally circulated *Current Law Index* is evidence of its growing stature as a reference work. On behalf of the student staff, we all express our deepest appreciation to David for his generosity and determination to maintain the highest possible

quality of journalism for our readership."

Eileen Kelly Dossin, the Assistant Dean for Alumni Relations and Development, commented on the gratifying financial support.

In addition to engraved certificates, each recipient received cash and an inscribed plaque will be hung in the Law School.

Mr. Moffitt plans establishment of similar scholarships for student staff members of the *Michigan Tax Law Journal*, another Bar Association service publication published at the Law School. An announcement of this scholarship program will be forthcoming.

Mr. Moffitt practices commercial and personal injury litigation with the Birmingham firm of Alan R. Miller, P.C. While in law school, Moffitt served on the Editorial Board of the *Michigan State Bar Corporation Finance and Business Law Section Journal*, as Managing Editor of the *Journal of Urban Law*, and, more recently, co-published an article with well-known Detroit attorney B. I. Stanczyk in the *Federation of Insurance-Counsel Quarterly*.
